

**Electronic Voting Timeline Annual Election – No Acclamation:**

Process	Timeframe
<p><b>PRE-VOTING NOTICE:</b> The Association shall deliver by individual notice to members at least 120 days before the election or thirty (30) days before the deadline to opt out of Voting by electronic secret ballot.</p>	<p>January 7, 2025</p>
<p><b>OPT OUT DEADLINE:</b> Member may change their preferred method of voting from electronic secret ballot to paper secret ballot or paper secret ballot to electronic secret ballot no later than ninety (90) days before an election.</p>	<p>February 6, 2025 5 pm</p>
<p><b>CALL FOR CANDIDATES:</b> Give notice for members to self-nominate to be candidates in the director election (must be completed at least 90 days before the conclusion of the director election). Manager to verify candidates' eligibility</p> <ul style="list-style-type: none"> <li>. Bellwether to send nomination material to Manager for review by</li> <li>. Manager to send approval of FINAL NOMINATION MATERIAL by</li> <li>. Bellwether to MAIL NOMINATION MATERIAL by</li> </ul>	<p>February 7, 2025</p>
<p><b>REGISTRATION DEADLINE FOR CANDIDATES: (must be at least 60 days before the conclusion of director election):</b></p> <ul style="list-style-type: none"> <li>. Member submittal deadline to self-nominate for director election</li> <li>. Manager to verify candidates' eligibility</li> </ul>	<p>March 9, 2025 5 pm</p>
<p><b>GENERAL NOTICE:</b> Give general election notice by posting the following information (must be completed at least 60 days before the conclusion of the director election)</p> <ul style="list-style-type: none"> <li>. Date, time, and location where ballots are to be returned to the inspector of elections;</li> <li>. Date, time, and location of the member meeting where ballots are to be tabulated;</li> <li>. List of nominees (candidates) in the director election</li> </ul>	<p>March 10, 2025</p>
<p><b>ELECTION MATERIAL:</b> Mail to the membership at least 30 days before the conclusion of the election and to include:</p> <ul style="list-style-type: none"> <li>. Secret ballots and instructions;</li> <li>. Mailing and privacy envelopes;</li> <li>. Notice of date, time, location, website where the election rules can be found and any agenda for the member meeting;</li> <li>. Candidate and member election statements;</li> <li>. Website where the election rules can be found</li> </ul> <p>BELLWETHER to send election material to Manager for review by            Manager to send approval of FINAL ELECTION MATERIAL by            BELLWETHER to Mail ELECTION MATERIAL by</p>	<p>April 9, 2025</p>
